Re: Approval/Withholding of admission for MBA Full time and MBA Evening Courses for the academic year 2018-19 in respect of College of Engineering Trivandrum - Order issued on 25.10.2018.

APPROVAL ORDER

The College of Engineering Trivandrum, in short the college, submitted the list of admitted candidates and supporting documents for MBA Courses, for the academic year 2018-19, for approval from Admission Supervisory Committee(ASC).

The ASC provisionally approved the Prospectus as per the order no. ASC 100/18/MBA/CET dated 14.02.2018. The college has got extension of approval from the AICTE and KTU for the academic year 2018-19 with the sanctioned intake of 120 for

Full time MBA course. The total admitted strength for the current academic year for the Full time course is 114.

The college further forwarded an email dated 24.10.2018 stating that candidates, Abin Oscar and Aliya Thaha have discontinued from the course. Hence the remaining admitted strength in full time course for the current academic year is 112.

The ASC has scrutinised the entire documents submitted by the college and found that the documents of 109 candidates are found acceptable. Therefore the admissions of the **109** candidates are hereby **approved** as per the below appended list.

Three (03) Candidates viz A S Athira, Manna Starry and Sruthi Leon have not produced the degree certificate. Hence their requisite qualification cannot be evaluated. Therefore the admissions of above three candidates are **withheld** subject to the production of their qualifying certificates.

The Principal of the college is directed to communicate to the above withheld candidates about their withheld status and the required documents shall be produced before the ASC, to cure the defects.

Until the withheld candidates are approved, they shall not be registered for the first trimester examination by the University.
